# DESCRIPTION OF THE TASKS TO BE PERFORMED IN THE PROJECT/KNOWLEDGE TO BE ACQUIRED AND/OR SKILLS TO BE DEVELOPED

Tasks to be carried out as part of project PID2019-105020GB-I00:

- 1.- Obtaining electrophysiological recordings in the cerebral cortex of animals (mouse) with spinal cord injury, under conditions of anaesthetised and awake animal with cranial fixation.
- 2.- Surgeries for spinal cord injury and intracranial injection of viruses for expression in neurons and glia.
- 3.- Development of procedures for analysis (programming of scripts in Spike2, Phyton, etc.) of electrophysiological signals.
- 4.- Animal behavioural tests for the study of motor and sensory functions.

#### MOTIVATION

Recruitment of research staff with experience in the experimental techniques in electrophysiology and neural signal analysis described in the project and in this call is required. The need for recruitment is described in the original project due to the workload that is foreseen to achieve the proposed objectives.

#### **SELECTION PROCESS**

The selection process will consist of two phases:

**1st Phase: Evaluation of merits** (6 points): in this phase, an evaluation of the merits and requirements established in the call for applications will be carried out by the Selection Board.

**2nd Phase: Personal interview** (4 points): Candidates who have obtained at least 4 points in the 1st Phase will be called for a personal interview with the Selection Board, which may be held in person or online. This interview will deal with the requirements established in the call for applications.

#### ADDITIONAL INFORMATION

- 1.-The resolution of the present call for the recruitment of personnel is subject to the prior authorisation of the Ministry of Finance and Public Administrations of the Junta de Comunidades de Castilla-La Mancha.
- 2.- It will be required to have the nationality of any country belonging to the European Union or, failing that, to be in possession of a work permit.
